ORDER

The Kerala State Land Use Board was constituted as per G.O.(MS) 21/75/Plg. dated 14.4.1975.

2. The Board operates Plan & Non Schemes under the soil and water conservation schemes of the State Plan with Head of account 2402-001 under Demand "Agriculture". Since 1975 this Board has been functioning without Special Rules. All the temporary posts of technical staff created in the Kerala State Land Use Board for carrying out specific projects during the past years were usually filled up on deputation from other departments. Hence a permanent staff pattern has not been finalized. The Special Rules prepared for the Board is under the consideration of Government.

3. The Secretary, Kerala Public Service Commission vide their letter read as 2nd paper above requested Government to clarify whether the Kerala State Land Use Board was constituted as a Statutory Board.

4. This issue was examined by Government in detail.

5. All the appointments in the subordinate service in the Board are being made through Kerala Public Service Commission since 1978 as in any other Government Department.

6. In the category of Lower Division Clerk, Driver, Peon etc., interdepartmental transfers and postings under compassionate employment scheme are being effected in the Kerala State Land Use Board since 1978.

7. In the Government Order sanctioning revision of pay of Government employees, the Kerala State Land Use Board is noted as a Government Department. The Kerala State Land Use Board is enlisted as a Government Department in all reports of Government such as Government Diary and official website.

8. Considering all the above facts, Government have decided to declare the Kerala State Land Use Board as State Government department and they order accordingly.

9. The Land Use Commissioner will function as the Head of the Department.

10. Orders on inclusion of the services under Kerala State Land Use Board under Rule 7&8 of KCS(C&A) Rules, notifying the Land Use Commissioner as Head of the Department and including him in the list of Head of Departments in Appendix II of K.S.R and in App.I of K.F.O.Vol. I etc. will be issued separately.


